## Six Appeal CONTRACT RIDER

## **Additional Contract Provisions:**

- 1. PURCHASER to provide at least 2 students to assist in both load in and load out of equipment at the Arrival Time
- 2. PURCHASER to provide a designated, coned off parking area to accommodate a Large Van pulling a Trailer (50-60 ft. total length pull through parking spaces are HIGHLY preferred).
- 3. PURCHASER to provide minimum stage area of 20 ft. wide by 16 ft. deep (Stage must be stable, level, and stage sections must fit firmly together, Six Appeal has a very high energy show so stage stability is of high concern).
- 4. PURCHASER to provide one person and one table to sell ARTIST merchandise during the Performance Time.
- 5. PURCHASER to provide one meal for 6. They prefer to have the meal on site at least 2.5 hours prior to performing. On site options or local restaurant catering is just fine! Please discuss options with Michael Brookens (620-381-3633) prior to the event.
- 6. PURCHASER to provide a designated dressing room/green room with no visibility from the outside.

  Dressing room must be able to accommodate 6 people and would preferably have a mirror in it. Generally a classroom, conference room, or large office with blinds or paper over the windows is acceptable. Please make sure this room is able to be locked while the group is on stage.
- 7. PURCHASER to provide a load-in area as close to the stage as possible. For venues not on the ground floor, an elevator is required to load in sound equipment.
- 8. If the Purchaser is to provide Six Appeal's hotel room, we ask for the following:
  - a) Hotel Room must be reserved at one of the following acceptable, national hotel chains: Hilton, Marriott and Marriott affiliated hotels, Hyatt, Double Tree, Embassy Suites, Crowne Plaza, Hampton Inn, Radisson, Sheraton, Westin, Wyndham, Holiday Inn and Holiday Inn Express ONLY. If one of these national chains is not available in your community, please note that the artist requests a hotel buyout equal to the amount you would normally pay for a hotel to be added to the Artist Payment. Please contact your Agent at The College Agency immediately if you do not have the ability to house the artist at one of the above listed hotels.
  - b) Hotel room must be reserved at a hotel that is located in an area of the town/city where someone can safely walk to nearby restaurants, stores, etc.
  - c) Hotel room door must not open to the outside, but rather the inside hallway or lobby of the hotel.
  - d) It is preferred that the hotel have a free continental breakfast
  - e) They would request that one room has a microwave and refrigerator if possible
  - f) Hotel must have Free hi-speed Internet access.
